DEED OF VARIATION relating to a Supplemental Funding Agreement dated 10 March 2015

## THIS DEED OF VARIATION is made on

21 DECEMBER

2016

#### **BETWEEN:**

- (1) The Secretary of State for Education ("Secretary of State"); and
- (2) Viking Academy Trust (formerly known as Chilton Education Trust), a charitable company incorporated in England and Wales with registered number 09449979 ("Company"),

together referred to as the "Parties".

#### INTRODUCTION:

- (A) The Parties entered into a master funding agreement dated 24 February 2015 ("Master Funding Agreement") relating to the establishment, maintenance and funding of academies.
- (B) Supplemental to the Master Funding Agreement, the Parties entered into a supplemental funding agreement dated 10 March 2015 ("Supplemental Funding Agreement") relating to the establishment, maintenance and funding of a 'independent school known as Ramsgate Free School.
- (C) The Parties now wish to vary and amend certain terms of the Supplemental Funding Agreement and wish to record their agreement as to such variations/amendments to the Supplemental Funding Agreement by this Deed.

#### IT IS AGREED as follows:

- The Secretary of State and the Company agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
- 2. As varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.
- 3. This Agreement shall be governed by and interpreted in accordance with English law.

This document has been executed and delivered as a Deed on the date stated at the beginning of this Deed.
